Introduction

This booklet has been prepared by the Department of Social Welfare on the recommendation of the Health, Education and Welfare interdepartmental Committee. (The H.E.W. co-ordinates activities and policies within the three departments. Associated with this committee is the standing committee for facilities and services for disturbed children). This booklet contains information on the types and range of services available to disturbed children who are not intellectually handicapped.

The H.E.Wworking party definition on disturbed children is children or young persons whose consistent behaviour gives rise to concern of parents, teachers or significant others or which brings them into conflict with authority, or is not conducive to their harmonious personal development and/or social interactions with their families, peers and others in the community.

Within this booklet is a list of facilities and services provided by the Department of Social Welfare, as well as a list of those run by private and voluntary organisations which may be able to help disturbed children.

It includes a breakdown on these services throughout the Social Welfare districts.

Although all the facilities listed in this booklet are able to cope with disturbed children (though the degree of disturbance with which they can cope may vary), most were not originally designed for this purpose.

Anyone encountering difficulty in locating a particular service should contact the local office of the Department of Social Welfare. An additional list of all local social welfare organisations is also published near the back of the Yellow Pages in each telephone directory. A list is also usually obtainable from a Citizens Advice Bureau. Additional details of educational services that may be able to help with disturbed children are available and it is recommended that the annual publication "Directory of Special Education and Guidance Services in New Zealand" issued by the Public Relations section, Department of Education, Wellington be consulted as a companion guide.

Whilst every care has been taken in the preparation of this booklet, which will be reviewed annually, it is hoped that any omissions or errors will be brought to the notice of this Department.

Functions and Resources of the Department of Social Welfare Related to Disturbed Children

The Department was established under the authority of the Department of Social Welfare Act 1971, and came into being on April 1 1972.

It was established in order to reduce fragmentation and overlapping of social work and welfare services in New Zealand.

The aim of the Department is to provide for the development of administration of effective social welfare policies and social welfare services for New Zealand and to promote co-ordination of social welfare activities.

Section 4 of the Act describes the Department of Social Welfare's functions. In regard to disturbed children the department is also responsible for administering;

(i) The Children and Young Persons Act 1974:

Provision of preventive and social work services for children and young persons whose needs are not being met by parental or family control and who could become in some way neglected, disturbed, ill-treated or offenders against the law.

The Major Social Work Functions Regarding Children and Young Persons

Personal and Family Services

Much of this work will arise from child care and protection referrals and will be consistent with the preventive provisions of the Children and Young Persons Act 1974. Functions of these services include long or short-term casework with individuals, groups or families, with emphasis on their personal and social needs.

- Arranging appropriate training for mentally, physically, socially and emotionally handicapped people.
- Casework and groupwork with unmarried parents.
- Liaison with doctors and specialists to help rehabilitate disabled children and young persons.
- Liaison with schools.
- Attendance to a wide variety of duties involving enquiries from the public and assistance to persons of any age seeking help.

Court Work, Child Care and Protection and Adoption

- Investigating complaints and referrals concerning care and treatment of children.
- Police aid section liaison.
- Investigating all cases involving children or young persons under 17 years coming before the Childrens and Young Persons Court because of an offence or complaint of being in need of care, protection and control -

section 27 of Childrens and Young Persons Act.

- Oversight of children placed by the Court under the supervision of a Social Worker.
- Care of children placed under the guardianship of the Director-General of Social Welfare in foster or family group homes.
- Section 11 Care and control (not guardianship) of children under custody of the Director-General which is arranged with the parent's consent.
- Investigation to ensure adequate provision for children born out of wedlook.
- Reports to court on applications for adoption.
- Reporting to court on custody of children in matrimonial proceedings.
- Licensing of foster parents boarding children under 6 years. Care of the children is supervised.

Residential Services and After Care

Refers to responsibilities under the Childrens and Young Persons Act 1974 of providing for the care, education and treatment of children and young persons placed in the Department's national and local institutions providing for long term or short-term care for assessment, training and placement in the community.

Also Social Workers may be involved in co-operation and co-ordination with psychiatric social workers in aspects of work with persons discharged from psychiatric hospitals.

Registered Homes and Day Care Centres

Registered childrens homes, child care centres and other organisations.

- Inspection of Childrens Homes run by voluntary organisations and co-operation with staff. Administration of subsidies to homes.
- Licensing and supervision of child care centres to ensure that standards are maintained.

Community Welfare and Voluntary Agency Liaison

Social Workers are expected to develop a wide knowledge and understanding of the community in which they work by gaining knowledge of and establishing liaisons with other government social work services and non-statutory agencies.

Contacts with police, teachers, clergy, doctors, counsellors and others involved in the community should be established in a way which will benefit the community.

NATIONAL INSTITUTIONS - AN INTRODUCTION

National Institutions provide long term training for children who have repeatedly offended or whose other placements have failed. Most are admitted under Guardianship Status and are proposed by local DSW districts and selected by Head Office DSW staff.

The length of stay varies depending on the institution and could be from three months to two years. There is variation within an institution itself in regard to length of stay as childrens needs differ and for this reason length of stay is not recorded in this summary of National Institutions. National Institutions are not regarded as the end after a series of failures and are often successfully employed early in a plan of treatment rather than later as a last effort. Placement in a National Institution should be a planned procedure and should be approached extremely cautiously.

It can be seen from the directory that Social Welfare institutions vary in their capacity to cope with disturbed children. Some institutions deal exclusively with emotionally disturbed children, while others are only able to cope with small numbers. All institutions, even though they might not have specialist psychiatric services, try to help disturbed children within a normal type of environment which also involves a school programme. The institutions do not provide a "sickness" model for treating disturbed children.

Highly aggressive girls not admitted and in general the institution is not used to rehabilitate girls who have been psychiatric hospital patients. Where appropriate the institution is prepared to admit a girl on trial and act as an intermediate type institution to try to avoid further psychiatric hospitalisation. There is a family home attached to the institution.

- This institution is in an open type rural setting and contains a full range of facilities, including a school. (Two teachers). Many of the girls are emotionally and/or socially deprived and academically underachieving, in spite of having normal intelligence. The institution is able to cope with a small number of emotionally disturbed children by balancing this group with the inside range of behaviour in other girls.
- The programme is general and individualised and counselling is provided. At times, when appropriate the local community help in social rehabilitation.

REGIONAL INSTITUTIONS - AN INTRODUCTION

The 13 regional institutions run by Social Welfare provide a short term residential service for the whole of the country. They cope with a wide variety of children, including those who are emotionally disturbed, from varying backgrounds. Some children are transcient and are under various processes of the law due to delinquency, while others are admitted for short term treatment, training and assessment. Children can be admitted for care due to parental neglect or disturbance and emergency admissions are accepted. The length of stay, where possible is generally not longer than three months.

Access to a regional institution is generally determined by a senior social worker or a liaison social worker employed by the district administering the institution. They are not under national control and most admit children from a wider area than their own districts. Any admissions from outside the controlling district are usually also screened by the same social worker.

Admissions can be arranged under a Guardianship order or a section 11 Agreement (voluntary). Other admissions are as a result of decisions made by the Childrens and Young Persons Court, and there is also social worker involvement here. Admissions may be made by the Police on a warrant.

Regional institutions provide assessment and observation programmes and nearly all have fully equipped schools with their own teaching staff. School Psychological Services provide the psychological back up, and in some institutions there is access to specialist resources either within the home or from the nearest clinic.

Adequate medical facilities are maintained and there are regular visits from medical staff.

Although most regional institutions have to function in a general way because of the wide demands of types of admission there is some degree of difference of functions in institutions in larger areas. This division is in the restriction in certain age groups and in some institutions in providing a service more in the remand and assessment areas. Local variations also exist depending on the gaps in the services that the community provides for children. In some areas psychiatric back up to the institutions has to be provided for children who obviously need psychiatric treatment, but no facilities exist. The regional institutions are a valuable asset for the local community but are frequently unknown and misunderstood. They provide a 24 hour crisis service every day for an extremely wide range of disturbance mostly for the 13-15 year age group. Younger children are not usually admitted and if residential facilities are needed specialised family homes or the reception centres are better. It is also not generally appropriate to admit children over the age of 16.

RECEPTION CENTRES - AN INTRODUCTION

Reception centres take in young children from pre-school to primary school age, and are designed to avoid admitting young children to regional institutions. These young children mainly come from situations where there is a breakdown in the family due to a separation, desertion or psychiatric disorder. At times reception centres take in all the children in a family and hold them until they can be placed in a family situation.

Because of the nature of circumstances in which these young children are admitted to the reception centres, there is usually a high degree of emotional disturbance amongst them.

These centres run a wide range of services from kindergarten programmes to primary school type programmes. Primary school children are usually integrated with local schools. Whenever possible work with the family is maintained with the DSW Social Worker and the staff of the institution counsel and support the children. Admission is via the liaison social worker in the district running the centre. Children may be admitted voluntarily under a Section 11 Agreement or under a guardianship order.

FAMILY HOMES - AN INTRODUCTION

Family homes are homes administered by the DSW and managed by "foster parents" who live with the children admitted to them along with their own families. The homes are built to take up to 6-8 children in addition to the foster parents children. Although not specifically designed to take in highly emotionally disturbed children they do cope with a wide range of emotional disturbances in some children.

Some family homes have become quite specialised in coping with emotionally disturbed children, e.g. the Linden Family Home and the Kibblewhite Road Family Home. Other family homes have specialised and have become hostel like homes catering for working children. Some homes admit young children who are in "at risk" situations.

The degree of specialisation within each home depends generally on the skills of the foster parents, the demands made by the community and the back up given them by the Department and specialist services. Admissions are usually made through the District Office and a liaison social worker, who discusses the admission with the "foster parent". Children can be admitted under a variety of supervision orders or under a voluntary Section 11 Agreement.

FOSTER HOMES

- 1. Foster homes, although not listed in this directory, are a form of residential services which do at times cater for highly disturbed children.
- 2. Such a home is occupied by a married couple and any children they may have and the foster child who may be under the guardianship of the D.S.W. or the subject of a voluntary agreement. In some areas foster home and family home foster parents have access to holiday camps or other holiday facilities such as converted country schools.
- 3. Application for admission can only be made through the Assistant Director (Social Work) at the D.S.W. in whose area the home is.

Residential Services Provided by Voluntary Organisations

A number of organisations not directly associated with the State run a complementary system of child care. Some organisations such as the Church run social services, provide a very extensive service and place emphasis on preventive work with families at risk. The main residential facilities are listed in this booklet in the knowledge that this is not the only form of help available for disturbed children.

All the voluntary homes listed in this section are registered by the D.S.W. as childrens homes. They are administered by voluntary organisations and are found throughout a large number of social welfare districts. The D.S.W. has a subsidy programme (capitation and capital subsidy) to assist in the running of the homes and where a child is under guardianship of the Department of Social Welfare the agency will receive the normal board rate (instead of the capitation subsidy).

The homes function similar to D.S.W. family homes with foster parents living with the children. Most homes were not originally designed to provide residential facilities for disturbed children and some homes have had the flexibility to develop a specific programme. Most homes cater to some extent for a degree of disturbance in children.

For the purposes of this booket each facility has been given a code number which indicates the degree to which the home specialises in the care of disturbed children. These range from 1 to 3.

- 1. Indicates that the home has specialised in the care of disturbed children.
- 2. Indicates that the home cares for a moderate proportion of disturbed children.
- 3. Indicates that the home has only minimal facilities for caring for disturbed children, and as such takes in only a small number.
